

# Minor Participant Waiver, Release, Indemnification of All Claims & Covenant Not to Sue

**NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. Read this document carefully and in entirety. By signing this agreement, you give up your right and the named minor's right to bring a court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of the named minor's participation in any Camp Fire Heart of Iowa ("Camp Fire") activities, now or any time in the future from Camp Fire and its affiliates.**

## Acknowledgment of Risk

I, in my legal capacity as the parent/guardian of the minor named below, do hereby acknowledge and agree that participation in any Camp Fire activities comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with Camp Fire participation, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with Camp Fire participation and that said list in no way limits the operation of this Agreement.

## Waiver, Release, Indemnification & Covenant Not to Sue

I further certify that the named minor is in good health and has no conditions or impairments which would preclude his/her safe participation in Camp Fire activities.
